I have been employed by Spartan Sewer Raider since May 2023. There have been seven occurrences within the last several months that were not processed through the payroll company. Once a remittance was made late that resulted in taxes paid and a stub issued. On another occasion the payment was made prior to the issuance of the check. However, 2 checks were issued in December that were never processed through the payroll company. This is resulting in the year end-total to be in-correct as the taxes were never paid. The year end tax form reflects this. I was only provided one tax form as this is the only type applicable.

I was hired as a W2 employee at \$18 an hour. I receive no commission, or any other payment-only my hourly rate. All the payroll company processed stubs reflect this. The hand-written checks are in the net amount. The last 2 in 2023 are NOT reflected in the totals.

I am enclosing 3949-A as tax information provided on year-end tax forms are in-correct.

What am I to do as the reporting is in-correct? How do I adjust for this when I do my personal taxes?


